2. Functions.

The functions of the Samiti will be to advise the Ministry regarding progressive use of Hindi in official work.

3. Tenure.

The term of the Samiti will be three years from the date of formation provided that:-

- (a) Members of Parliament who are the members of the Samiti shall cease to be members as soon as they cease to be Members of Parliament.
- (b) Ex-officio Members of the Samiti shall continue as Members as long as they hold the office by virtue of which they are Members of the Samiti.
- (c) If a vacancy arises, on the Samiti due to resignation or death of a Member, the Member appointed in that capacity shall hold the office for the residual term-for three years.

4. General

Headquarter of the Samiti will be at Udyog Bhawan, New Delhi, but it may hold its meetings at any other station also.

5. Travelling and other allowances

The non-official members will be paid Travelling Allowance and Daily Allowance for attending the meetings of the Samiti at the prescribed rates as amended from time to time by the Government of India and instructions contained in O.M.No. II/20034/4/86-OL (A2) dated 22 January, 1987 of the Department of Official Language.

Order

Ordered that a copy of the Resolution be communicated to the President's Secretariat, the Prime Minister's Office, Lok Sabha Secretariat, Rajya Sabha Secretariat, Cabinet Secretariat, Planning Commission, all the Ministries and Departments of the Government of India, Office of the Comptroller and Auditor General of India, all the Members of the Samiti and all State Governments and Union Territory Administrations

Ordered also that the Resolution be published in the Gazette of India for general information.
